

## CRUISE CERTIFICATE DRAWING - OFFICIAL RULES

**1. NO PURCHASE NECESSARY TO ENTER TO WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.** Open to legal residents of the continental US only, who are at least 18 years of age as of June 17, 2009.
